Reciprocal vessels must haulout by Oct. 14, 2016

- Procedure to arrange Haulout and Launch. The Haulout Schedule is posted online at pcyc.net/harbour-grounds/haulout-schedule. Check the date and time you would like to be hauled out for availability. Note: Some days have been designated as Power Boats only and some have been designated as Sailboats only. Only completed forms dropped off with FULL payment and insurance at the Communication Center will be processed. Sailboat masts will be un-stepped at the same time if the mast has been scheduled. Shortly after haulout, your exact launch date and time will be posted online.
- **2.** Note: You or your authorized representative must be in attendance during the haulout and launch. If you are not launched on your assigned launch date, you will be subject to a relocation charge and storage charge to cover the cost of relocation and late launch.
- **3.** The Winter Storage Fee covers haulout, storage, a bottom spray and launch (mast un-stepping and stepping is available for a specified fee overleaf) during the times specified by the Club. Any relocation of your boat will incur additional charges as posted by the Club, and the applicant hereby agrees to pay such charges.
- **4.** No vehicles, boats, trailers or motor homes stored on land on Club property may be used to provide living accommodations.
- **5.** All vehicles, trailers, vans, cube trailers, runabouts and Tender Dinghy's to be stored, must have the Harbourmaster's prior approval and will be billed accordingly.
- 6. 110 -Volt electrical services will be available to boats stored on Club property only between 0800 and 1600hrs and <u>only</u> while the owner or the owner's representative is in attendance. Cords found plugged in when the owner / representative is not present will be disconnected. Cords or hoses left on the ground will be removed.
- 7. Boat owners are responsible for the safety and security of their vessel at all times, especially in the event of severe weather conditions. Ladders and other means of access to the vessel must be put away and secured to prevent unauthorized access to the owner's boat and others. Portable Fuel and propane tanks must be removed. Any re-fuelling of vessels on Club property is strictly prohibited
- **8.** Additional charges will apply for blocking, cradle storage, mast stepping and un-stepping.
- 9. Cradles must adhere to our specifications, be of steel construction and fold. <u>Wood cradles are not allowed.</u> Cradles may be purchased from the Marine Cradle Shop. Tell them you are storing at PCYC and they will provide storage blocks and build the cradle to our 96" width restriction. Call Mark Jacobs at 905-294-3507. Cradles without welded storage blocks are subject to welding & blocking charges. Stands may be purchased for power vessels from Kropf Industrial, 1-705-378-2453.
- 10. All boat owners using stands will be required to pay a blocking charge. PCYC does not provide stands.
- **11.** Materials rented from PCYC for blocking are rented for the duration of storage and may not be removed from the site.
- **12.** Sailboats may be stored with their masts stepped, provided they are in a suitably secure cradle.
- **13.** Un-stepped masts must be stored in the mast racks and will be charged the applicable fee. Masts may not be stored on the deck, unless they do not overhang the vessel ends.
- **14.** Vessels must be immediately removed from the Club docks after launch.
- 15. INSURANCE: No insurance is carried by PCYC on Members' or Customers' boats or property. Storage thereof is accepted at the sole risk of the owner and the owner hereby releases and holds harmless PCYC, its agents and employees, from all claims for loss or theft or damage, whether due to the negligence of PCYC, its agents or employees, or to any other cause. All owners are required to carry insurance on their boats and equipment, and a minimum of \$2,000,000 Third Party Liability, proof of which must accompany this application before it can be accepted.
- **16.** This Winter Storage Agreement contains a Hold Harmless Agreement and your Insurance Policy must contain the following clause: Hold Harmless Agreements Permission is granted for the Assured to sign "hold harmless". agreements with Yacht Clubs, Marinas and other authorities where such agreements are necessary and customary.
- 17. This agreement is for the services listed above only, and such space and services, and PCYC equipment is to be used at the sole risk of the owner. PCYC shall not be liable for the care or protection of the boat (including her gear or equipment and contents), her passenger, crew or guest, whether due to negligence of PCYC, its agents or employees, or to any other cause. The owner agrees to indemnify and hold PCYC harmless against any loss, cost , suit or claim arising out of the use of the above mentioned space, services or PCYC equipment or any handling of the boat in connection therewith, whether or not such loss, cost, suit or claim is based upon the negligence of PCYC, its agents or employees, or to any other cause.
- **18.** ALL REQUESTS FOR CHANGES AFFECTING THE STORAGE OR LAUNCH OF A STORED BOAT AND EQUIPMENT MUST BE MADE IN WRITING TO THE HARBOURMASTER PER THE APPLICABLE HARBOUR & GROUNDS POLICIES.
- 19. I ACKNOWLEDGE PCYC'S RIGHT TO A LIEN PURSUANT TO THE REPAIR AND STORAGE LIENS ACT R.S.O. 1990 AND AUTHORIZE PCYC TO SEIZE AND SELL THE ABOVE DESCRIBED BOAT AND EQUIPMENT TO SATISFY ANY UNPAID PORTION OF THE STORAGE AND MOORING FEES. I FURTHER ACKNOWLEDGE THAT I SHALL BE RESPONSIBLE TO PCYC FOR ALL OF ITS COSTS FOR THE SEIZURE AND SALE OF THE BOAT AND EQUIPMENT INCLUDING, BUT NOT LIMITED TO: BALIFF/SHERIFF'S FEES, DAILY STORAGE FEES, ANY OTHER FEES NAMED BY THE SAID ACT.
